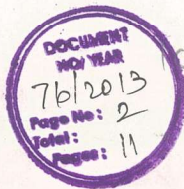

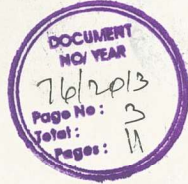

FOLLOWS:

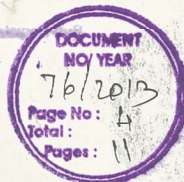
1. The Trust is hereby declared and constituted as Public Charitable Trust. The name
of the Trust is:

"VIDIYAL FOUNDATION"

2. The office of the Trust shall at present be located at:

Chennai - 600 125



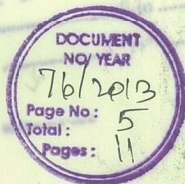

3. The objectives of the trust are:

- a) To support education for the students this includes children with physical disability and who are financially very weak.
- b) To establish Schools / Industrial Training Institutes / Arts and Science Colleges for the promotion of Education among the Public.
- c) To establish Care and Concern Centers for the Old Age people to get Counseling, Medical Care and Home for the Abandoned.
- d) To organize general health camps and health awareness for the benefit of the Slum and Rural community.
- e) To aid, support, subscribe or give donations to other public interested organizations to carry out the similar activities for the development of the general public.
- f) To establish Children's Home / Orphanage for the Orphans, Semi Orphans, poor children and provide food, shelter, education, health care and recreation to live better in the society.
- g) To promote environmental education, tree plantation and water management to keep the nature of the rural community.
- h) To create community based rehabilitation programme for the welfare of the mentally and physically handicapped.

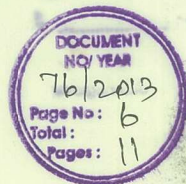
4. The trust shall be managed by a Board of Trustees, which shall consist presently of:

- a. Mr. A. BALAJI S/o Mr. S. Anantha Narayanan, aged about 32 years, residing at Plot No. 17 Subhasree Nagar, 8th cross street, Mugalivakkam, Chennai – 600 125

- b. **Mr. M. PRASAD S/o, Mr. S. Mani** aged about 43 years residing at Plot 136 Flat 1 Adithya Hridayam, Silappathigaram street, Ganesh Nagar, Selaiyur, Chennai – 600 073
- c. **Mrs. Preetha Prasad W/o Mr. M. Prasad** aged about 35 years residing at Plot 136 Flat 1 Adithya Hridayam, Silappathigaram street, Ganesh Nagar, Selaiyur, Chennai – 600 073
- d. **Miss. V. Srividhya, D/o Mr. R. Vaidyanathan**, aged about 30 years residing at No.9A/5A, Sri ranga flats, Shyamala vadhana street, West mambalam, Chennai – 600 033.
5. The Founder Trustee **Mr. A. BALAJI** and the Trustee **Mr. M. PRASAD** as mentioned in a) and b) of para four herein after above shall be called **Life Trustees** and shall hold the office of the trust till their lifetime.
6. **Mr. A. BALAJI** (Founder Trustee) shall be the **Managing Trustee** and **Mr. M. PRASAD** shall be the **Financial Trustee** for life or till they resign.
7. The Board of Trustees shall co-opt if found necessary any other person or persons as trustees but at no point of time such co-opted trustees shall exceed two in number. The office of trust for the trustees, other than life trustees shall be for a period of three years only and they are eligible for reappointment, with full consent of the Managing Trustee and Financial Trustee. The life Trustees have full right to select co-opt trustees.
8. Any trustee shall be liable to be dismissed from the trusteeship if he is adjudged insolvent or found insane or guilty in a court administering criminal law. A trustee shall be liable to be expelled from trusteeship if his or her actions are adverse to the interest of the trust.
9. The funds of the trust herein before conveyed will form the corpus of the trust to which shall accrue all future accretions, profits, income, donations, properties that may be earned or received hereafter.

10. The trustees shall at no time be entitled to appropriate to themselves any revenue or funds of the trust by way of profits, interest, dividend, etc, except any amount that may be reimburse out of the actual expenditure incurred by them on behalf of the trust. The services of the trustees are purely honorary.
11. The Board of Trustees shall have powers to: -
- Receive and accept contributions, donations, gifts in money or property or any kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the trust and such contributions shall be dealt with either as capital or as income according to the directions of the donors at the time of gift of contributions and the board shall do all things as may be necessary to act upon the wishes of the donor.
 - Buy, sell contract, develop take on lease, exchange, grant transfer immovable property where it is deemed expedient or necessary for carrying out the objects of the trust with the prior permission of the concerned Commissioner of Income-tax *in future.*
 - Manage the trust, its properties and funds. They shall likewise be entitled to take all steps that may be reasonable or required for the preservation of the trust and the trust's properties.
 - Frame necessary rules and regulations for proper and convenient administration of the trust and to act according to such approved rules and regulations.
 - Help and assist in managing the funds of the trust for the fulfillment of the aims and objectives of the trust.
 - Borrow monies for the purpose of the trust at such terms and conditions as may be agreed to by the board of trustees and to authorize any one or some of them to execute such documents including the deed of mortgage, charge or hypothecator as may be necessary for the purpose and also to create any mortgage or charge of any of the trust properties movable or immovable for the said purpose.
 - To repay the loans out of the income derived from the trust properties, investments and funds or out of the donations specifically earmarked for the purpose of repayment of debts. or otherwise.

12. The excess funds of the trust after application towards the objects of the trust, shall be invested only in the modes specified under the provision of section 13 (1) (d) read with section 11 (5) of the income tax act, 1961 and / or as per statutory modification made in the income tax law from time to time.
13. The Managing Trustee and the Financial Trustee shall jointly operate Bank Accounts on behalf of the Trust. In their absence, any of the Trustees may be authorized by the Board of Trustees, by a resolution, to operate the bank accounts. One or more Bank Accounts may be opened in any Bank and or Banks in the name of the Trust.
14. The trustees shall arrange for the maintenance of correct and proper account of all receipts and payments for the period ended 31st March, every year and for proper audit of the account of the trust every year, by auditor (s) who are / is qualified to do the audit of trusts under the income tax act, 1961.
15. The trust is irrevocable.
16. In case of dissolution or winding up of the trust, funds of the trust shall be transferred to other trusts or societies or institutions having similar objects
17. The activities would be confined to the territory of India.
18. The trust shall not carry on any activities with the intension of earning profit.
19. The funds of the trust would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in section 13 (1) (c) of the Income-tax Act.
20. The benefits of the objects of the trust would be available to the general public irrespective of caste, creed, community, religion or sex
21. Not more than 5% of the income of the trust would be applied for any religious purpose or given to religious institutions.



20. The trust deed shall be amended in future, only after getting the prior approval of the concerned Commissioner of Income Tax.
23. The trustees may organize meetings as and when they think, fit to consider important matters with the trust and its management.

24. The trust does not have immovable property at the time of registration.

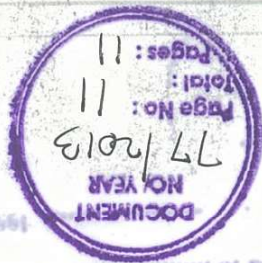
